 Jan Wallace spoke of her background in tourism and volunteering – the challenge she sees for the future in promoting the Community's great asset we have here at Archer Park – and the Council's requirement to restrict spending.


# The Museum

#### **Rail Safety & Safe Operating**

A number of Australian rail heritage operations have closed recently, temporarily we hope, after accidents or rail safety audits.

While each has generated considerable local publicity (and angst), and we wish them all the best for a speedy return to full operation, the bottom line is all railways must meet national standards for rail safety and safe operating.

Archer Park's continued accreditation depends on every volunteer being vigilant, following proper procedures and reporting errors, faulty infrastructure, accidents, etc.

Observe, report, document and ensure that the problem gets fixed!

# **RRC Personal Threat Policy**

The number of hold-ups, etc., in recent weeks suggests that Museum staff and volunteers should be aware of the RRC policy on Personal Threat – Armed Intrusion/Hold Up:

Personal threat may take the form of armed or unarmed confrontation. Unarmed confrontation may arise where there is a threat to others by a person confronting them in a violent/threatening manner.

#### **Basic principles**

- Remove as many people away from the situation as possible and prevent others from getting into danger.
- Always carry out the demands of the offender exactly, nothing more, nothing less.
- If company property is demanded, it should be supplied. Do not attempt heroics.
- Observe any characteristics of the intruder, which may assist in their detainment. This could include weapons involved, speech, mannerisms, clothing, scars/tattoos, names or nationality.
- When able to, contact the Police by dialling '000'.
  Ensure that by doing so, you do not endanger yourself or anyone else.

# For those not directly involved in a threat by an intruder:

- 1. Notify the Chief Warden and Management.
- 2. Contact the Police by dialling '000' and asking for Police.
- 3. Follow the directions of the Chief Warden or the authorised person in charge.

# Mt Morgan Rail Museum

## Mt Morgan Mining Railway


Gold Mining began at Mount Morgan in 1882, becoming the premier gold mine of the world about 1890, and from 1906 Mount Morgan became a major copper producer.


In 1927 the Company went into voluntary liquidation but was re-established in 1929 using open cut methods. It remained Queensland's major copper producer until the early 1950s.

The Mount Morgan Mining Company's various operations were serviced by Queensland Railways (initially QGR), with its 3' 6" gauge. However, the mine itself also had a network of 26" gauge track, as well as 24" gauge within the Copper Reduction Works.

It's fairly obvious that the 26" gauge was chosen because the narrower gauge required less space for operating within the mine and other works. While the gauge isn't as common as some others it may have been chosen by an engineer who had been familiar with it at another mine.

Choosing a different gauge for the Copper Reduction Works may have been the result of purchasing a complete set of special purpose equipment just for use in the works.
